

2025 P1FCU FINANCIAL LITERACY MONTH SWEEPSTAKES RULES

1. NO PURCHASE NECESSARY TO WIN. VOID WHERE PROHIBITED. P1FCU may change the dates, or terms of the sweepstakes without prior notice.
2. **Eligibility:** The 2025 Financial Literacy Month Sweepstakes is open to legal residents of the 50 United States and the District of Columbia, and who are 18 years of age and older at the time of eligible entry (see How To Enter). Sweepstakes is subject to all applicable federal, state, local laws, and regulations. Void where prohibited by law. P1FCU employees and immediate family members, board members, and supervisory committee members are not eligible to win.
3. **Sweepstakes Period:** The 2025 Financial Literacy Month Sweepstakes begins April 1st and ends April 28th.
4. **How to Enter:** Individuals may receive entries into the giveaway in the following ways:
 - a. Being subscribed to our Basecamp Newsletter during the month of April.
