



***Dave Instagram Giveaway* SWEEPSTAKES RULES**

- 1. NO PURCHASE NECESSARY TO WIN. VOID WHERE PROHIBITED.** P1FCU may change the dates, or terms of the sweepstakes without prior notice.
- 2. Eligibility:** The Dave Instagram Giveaway Sweepstakes is open to legal residents of the 50 United States and the District of Columbia, and who are 18 years of age and older at the time of eligible entry (see How To Enter). Sweepstakes is subject to all applicable federal, state, local laws, and regulations. Void where prohibited by law. P1FCU employees and immediate family members, board members, and supervisory committee members are not eligible to win.
- 3. Sweepstakes Period:** The Dave Instagram Giveaway Sweepstakes has multiple entry periods for multiple prizes. The promotion begins October 5th, 2024 at 12:00 am and ends November 19th, 2023 at 11:59 pm.
- 4. How to Enter:** We will be hosting multiple giveaways with multiple entry pools. Individuals may enter into each giveaway by completing the below activities. The third entry option will carry over throughout the sweepstakes period between each giveaway.
 - a.** Following "Dave's" Instagram Page (https://www.instagram.com/dave_govandals/) and sharing our giveaway post to your Instagram Story.
 - b.** Commenting on our giveaway post and tagging another Instagram account.
 - c.** Sharing a photo of you with "Dave's" life size cutout, found at the P1FCU tailgate at the game, and subsequently the Vandal Bookstore to your Instagram Account and tagging @dave_govandals in the post. This entry counts for every giveaway.

Entrants may use all three methods of entry to increase the number of entries they have.

- 5. Odds:** Odds of winning a prize depend on the number of eligible entries received for the drawing. In total, entrants may accumulate 3 entries in the sweepstakes.

The prizes are as follows: 10/14 a set of cornhole boards and an Owalla Tumbler, a value of approximately \$200, 10/21 14 a set of cornhole boards and an Owalla Tumbler, a value of approximately \$200, and 11/18 (grand prize) a set of cornhole boards, an Owalla Tumbler, a YETI Roadie Wheeled Cooler, and \$250 gift card, a value of \$850.
