To give members 18 years and older the opportunity to vote in the board election, we are offering three other voting methods this year in addition to in-person voting at the meeting. You may choose to vote online at a secured website, vote in one of our branches, or request a paper ballot. We want and value your input and encourage you to vote using whichever method with which you are most comfortable.

Voting Online

You may vote for the candidates of your choice by visiting our website, <u>https://www.p1fcu.org/meeting</u>. You will be asked to provide your member number and the last four digits of your social security number. The candidates will be listed; you then click on the ones you wish to vote for. You can vote online from Monday, January 6th, 2025, through Thursday, January 23rd, 2025, when ballots are called for during the Annual Business Meeting.

Voting In-Branch

Members 18 years and older may vote for the candidates of their choice by going into one of our branches and placing your vote in the ballot box. Voting will be allowed in-branch from Monday, January 6th, 2025, through Saturday, January 18th, 2025.

Voting by Paper

If you are more comfortable voting via paper ballot, call the toll-free number, 855-541-1452. You will be asked to provide your member number and the last four digits of your social security number. The ballot will be mailed to you and returned via an enclosed postage-paid envelope. Your ballot must be received by January 23rd, 2025.

Voting at the 2025 Annual Meeting

Members 18 years and older may vote for the candidates of their choice by attending the 2025 Annual Business Meeting, which will be held at 6:00 pm on Thursday, January 23rd, 2025, at the P1FCU Administration Center located at 1025 Warner Avenue in Lewiston, Idaho. Members of all ages are encouraged to attend the Annual Meeting.
